## Background:

Essex County Council has been administering the Flood Grant since 2014. The scheme pays for the installation of flood protection products to homes such as Flood Doors, Flood Barriers and Anti-flood Air Bricks.

You can apply for a grant if you have been affected by internal flooding from local sources such as rainfall, watercourses and groundwater, or if you are at risk of flooding.

Homeowners which have received the grant have cited 'choice of products', 'quality of flood doors' and 'good, tidy installation service' as a few key reasons why they are happy with the scheme.

The scheme has also received significant backing from the Council. Councillor Walsh, Cabinet Member for Environmentand Waste, has said that "It's the busiest period we have ever seen. This grant has been hugely successful and helps to put residents' minds at ease after being affected by flooding".

## Client Brief - Aims & Objectives:

- Completely and autonomously manage the scheme
- To process a minimum of 60 applications per year
- To carry out a minimum of 40 installations per year with certified, trained and experienced installation teams
- To appoint and project manage the independent RICS-certified Flood Risk Surveyor
